LONDON SWISS PHILATELIC SOCIETY.


The 82nd Meeting of this Society was devoted to a study of part of one section of the superb collection of the stamps of Great Britain gathered together by Mr. H. C. V. Adams, F.R.P.S.L. It might convey some idea of the importance of the collection to add that it gained the Exhibition Trophy at the International Exhibition held as Grosvenor House last year.

The portion commented upon and shown by Mr. Adams was devoted to the issues of King Edward VII reign. The original and various suggested designs were accompanied by die proofs, and experiments in various colours and kinds of ink. A large proportion of these were unique.

The famous "Tyrian Plum" 2d. value which was prepared for use but never issued owing to the death of King Edward was represented by die proofs in the issued colour. Only one unused and one partly used copy of the stamp itself exist, both being in the Royal Collection.

A remarkable rarity included was the 1/- value in which His Majesty appeared adorned with an immense square cut beard owing to a defective printing. It is said that only six copies of this exist.

Mr. E. Miller, himself a specialist on the stamps of Great Britain, and Mr. Meier-Tissot, both spoke to the vote of thanks which was carried by acclamation.
