## SWISS MERCANTILE SOCIETY.

No more than three dozen members were present at Swiss House for the monthly meeting on 8th inst. Messrs. J. J. Boos, Willy Deutsch and H. Knoll excused themselves for non-attendance.

Mr. J. J. Schneider, our secretary, was still in hospital at University College with knee trouble. There was some improvement to report but the time of his discharge from hospital was not known yet.

We had no new members enrol, but had to accept the resignation of Miss A. Wiesmann, who had returned to Switzerland.

Arising from the minutes, the President informed us that a room was now available at Swiss House every Wednesday evening for members who may wish to play cards or meet socially.

The enquiry sent out to members asking what type of social gathering they preferred this winter had been answered by few only. The replies showed a slight preference for a lunch and tea, instead of a dinner and dance.

With regard to the winter programme we were informed that, through the kind intermediary of Mr. Gottfried Keller we shall have the pleasure of hearing Mr. S. H. Woolridge, formerly Consul at Strassbourg, at our November meeting, on the European Federation, the Schumann plan, and kindred matters.

The Presidents Assembly has now handed the question of the Swiss Youth Centre in London over to the Organising Committee appointed for the purpose, on which our trustee, Mr. F. G. Sommer, and our member Mr. A. Stauffer, Editor of the Swiss Observer, are serving. It is intended to launch an appeal for funds in Switzerland before Christmas. Mr. Mock stated that our General Secretary, Mr. P. Schmid-Ruedin, was putting this project before the Federal authorities to ascertain what support we may expect in that quarter.

Mr. Reymond Chappuis, who had just returned from holidays in Switzerland, brought us the greetings from our corresponding members Messrs. Jean Trachsel and Maurice Bornand.

At this point we went over to the entertainment of the evening. We were shown three films lent to us by the British Transport Commission. The first one dealt in considerable detail with the organisation and machinery of unloading and loading a cargo cum passenger steamer in the port of Hull. At the end one appreciated why the Army always seems a poor substitute, during strikes, for the highly specialised labour force which handles, with extraordinary efficiency, the huge and varied cargoes which enter and leave this country through its ports. Film two was a humorous sketch showing how a family moves from their old home to new quarters, the lesson being, "Leave it to the British Railways and Road Services and you cannot go wrong". The third and last film initiated us the maintenance service of London's Underground which is being overhauled every four years. — To judge by the comments overheard after the meeting, these films belong to the best and most instructive we have seen at Swiss House, and we are grateful to our principal Mr. Slade, for drawing our attention to this service of the British Transport Commission.
