H. OSWALD.


President : Swiss Economic Council.

R. DE CINTRA. President : Swiss Sports Committee.






Mrs. C. BERTI. President : Unione Ticinese (Ladies Section).



HANS BERLI.


President: Swiss Club, Balloch.
