LONDON SWISS PHILATELIC SOCIETY. Annual General Meeting and Luncheon.

The London Swiss Philatelic Society is one of the Swiss Societies, which does its work in a quiet and unobtrusive manner, and only comes once a year really to the notice of a wider public; when they hold their Annual General Meeting. To make it a real event, this meeting is followed by a luncheon to which the Ladies are invited.

The name "London Swiss" Philatelic Society is perhaps not quite accurate, because amongst its members there are quite a number of Englishmen, but this "blending" is an undoubted success and seems to add

to the gaiety of these luncheons.

It is said, that every man should have a hobby of some kind to prevent him becoming dull and getting into a groove, once the time for retirement comes along; but in this age of hustle and bustle few have time to indulge in hobbies and fewer still, unless they enjoy the benefit of a pension, have the necessary financial resources to retire, the Chancellor of the Exchequer sees to that.

However, those who have chosen stamp collecting as a pastime have chosen well and wisely, as it is, undoubtedly, much less strenuous as f.i. gardening or wood-cutting, and as far as I can gather, it is also

The Annual Meeting was held on Saturday, January 26th, at the Glendower Hotel, Glendower Place, South Kensinggton, S.W.7, when the President, Mr. F. Streit, reported on the work and the financial position of the Society, the latter apparently showed a balance on the "wrong side". This grave statement of the President, however, did not seem to cast a gloom over the proceedings, and it was decided there and then to wipe out the deficit with the proceeds of a raffle, which was held later on during the luncheon and which once more put the finances of the Society on an even keel.

The election of officers followed and there being no nominations, the officers and committee members for the year 1952 were re-elected for a further term with the addition of Mr. W. R. Thompson, Hon. Treasurer and Mr. H. C. Gay, Hon Assistant Packet Superintendent. The President took this opportunity of paying a great tribute to the work of the late treasurer, Mr. G. Wahl, who departed from this life last year, greatly mourned by all those who came in contact with him. The Meeting was then closed and the members adjourned to the Annual Luncheon.
