ANGLO-SWISS CORONATION BALL.

**Friday, 5th of June, 1953, at Londonderry House,
Park Lane, W.1. from 9 p.m. to 2a.m.**

The Swiss Minister, Monsieur Henry de Torrenté in his address given at the recent "Fête Suisse" celebration, at Central Hall, Westminster, appropriately referred to the approaching Coronation of Her Majesty Queen Elizabeth, inviting the members of the Swiss Colony to associate themselves with the joyous and festive mood of this country.

The crowning of Britain's young Queen is not only for the people of Great Britain and the Commonwealth, a great and very happy event, but it will also have its repercussions in the hearts of all those who are enjoying hospitality in Her Majesty's realm.

Could there be a better opportunity to associate ourselves in these joyous celebrations in close union with our English friends, than by attending the Coronation Ball arranged by the Anglo-Swiss Society.

We feel sure that the English members of this Society would greatly appreciate, and consider it a compliment paid to their Queen, if they could spend that evening in the company of their Swiss members and friends.

As already mentioned previously, the invitation is extended to all members of the Swiss Colony, whether they belong to this Society or not, the aim of the committee is to see a truly representative gathering.

Many of the distinguished Patrons of the Society

have promised to be present and will thus give a certain *cachet* to this event.

A most happy choice has been made as to the setting for this Coronation Ball. Londonderry House with its fine ball-room, library, and other spacious rooms, its imposing staircase, will act as an ideal back-ground.

To enable every-one to take part, the price of the tickets have been fixed at a reasonable rate, viz. 27/6, which includes buffet, soft drinks and coffee; those who need stronger stimulants can satisfy their requirements at the various bars.

We sincerely hope, that many of our compatriots will give themselves rendez-vous at Londonderry House on the 5th of June, thus show our English friends how much we share with them this conspicuous and happy event.
