## CITY SWISS CLUB. Annual General Meeting.

The Annual General Meeting of the City Swiss Club, one of the last of the many annual meetings recently held, took place on Tuesday, April 27th, 1954, at the Dorchester Hotel, Park Lane, W.1, and was preceded by dinner.

The Easter holiday feeling still seemed to be prevailing in the Swiss Colony, and only about 50 members attended the Club's principal Meeting of the year.

Mr. R. Pfenninger was in the Chair, and in opening the proceedings, extended a hearty welcome to Monsieur E. Bernath, 1st Counsellor of Legation, thanking him for the continued interest he is taking in the affairs of the City Swiss Club.


The President informed the Meeting of the passing away of Mr. F. H. Rohr, a very old member of the Society, and asked the company to pay its usual tribute.

Two new members were elected, and there were two resignations.

Mr. Pfenninger then passed in review some of the activities of the Club during the last twelve months. "The various social functions held" he said, "proves that the City Swiss Club is far from a dormant concern". He said that it was gratifying to note, that the spirit of friendship and congeniality amongst the members remains on a high level.

The Hon. Treasurer, Mr. X. Speckert then presented the accounts, which made very pleasant reading. Whilst some of our Swiss Societies close their accounts with a balance "on the wrong side", the City Swiss Club is in the happy position of showing a substantial cash balance.

After a short discussion, during which it was



proposed, that a part of this balance should be earmarked for the centenary festivities, which will take place in two years time, the accounts were accepted with thanks to the Hon. Treasurer for looking so well after the Exchequer of the Club.

The accounts, separately kept, of the "Club House Fund" show a balance of £5,065.14.4 (April 1953: £4,887.4.8). These too were accepted and so was the auditor's statement read out by Mr. R. Weist, who was thanked for his audit.

The elections for the new Committee for 1954/55 then took place under the Presidency *pro tem* of Mr. C. Seinet, a former President of the Club.

Mr. Seinet, on behalf of the members present, thanked the outgoing committee for the services so well rendered, congratulating especially the late President for the humorous and congenial way in which he had conducted the Meetings.

He voiced his pleasure, that on various occasions the Ladies have been invited to take part at some of the social functions, and hoped that this new feature, so much appreciated by the Ladies, would be kept up in the future.

Mr. Seinet then announced that the following members had been duly elected: President: R. Pfenninger, Vice-President: Robert J. Keller, Hon. Secretary: Chas. Gysin, Hon. Treasurer: X. Speckert, Assistant Secretary: Henry Oswald, Assistant Treasurer: G. A. Ronus, Librarian: L. A. Chapuis (New), for Mr. Wustiner, who has left for Switzerland.


# " SWITZERLAND IN PERSPECTIVE ". An N.S.H. Talk.
