## AN ARRIVAL.

We have much pleasure to announce that Dr. Marcel Luy, 1st Secretary of Legation, has taken up his post at the Swiss Legation in succession to Dr. H. Miesch, who has recently been transferred to The Hague.

Dr. Luy was born at Sion (Ct. Valais) in 1917, where he received his schooling, after which he continued his studies at the "Handels-Hochschule", St. Gall, and the Universities of Munich and Fribourg; in 1944, he received his doctorate (rer. pol.) at the University of Fribourg.

On completion of his academic career, he occupied from 1942-1945, the post as assistant at the "Institut international des sciences économiques et sociales de l'Université de Fribourg".

In 1945, Dr. Luy entered into the service of the Federal Political Department (Swiss Foreign Office). Three years later (1948) he was appointed Acting Consul in Manila and Medan (Sumatra). In 1950, he was transferred to the Swiss Legation in Peking, with the rank of second Secretary of Legation, which post he held until 1952, when he returned to the Political Department in Berne.

On the 1st of January of this year, he was promoted to the grade of 1st Secretary of Legation.

We are wishing Dr. Luy a successful and pleasant stay in the Metropolis.

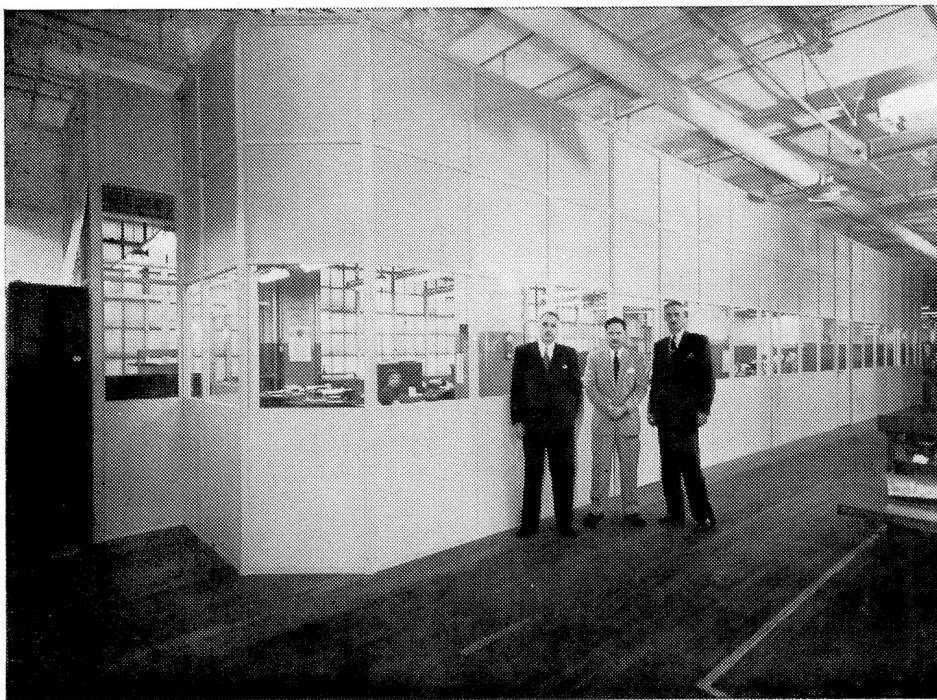
