WALTER GRADMANN †

On the 2nd of this month, Walter Gradmann died at a hospital at Edgware. Although he had been in ill health for some years, his untimely death came as a great shock to his family and friends.

A precarious health prevented him from showing himself often in the Colony, but his sterling qualities and high ideals were greatly valued and appreciated by his colleagues and friends.

Walter Gradmann was born at Augsburg (Bavaria) in December 1891, he went to school in Zurich, and later at the age of 24, gained his diploma as a mechanical engineer at the Federal Institute of Technology (ETH) Zurich. He remained at the University for a further two years, and in 1920, joined the firm of Sulzer Bros. in Winterthur, where he was employed for four years. In 1924, he married and came to London to join Sulzer Bros. (London) Ltd., where he was employed in various capacities, finally becoming Manager of the Steam Department, a post which he held for some years prior to his passing away.

We, who have known the deceased, and admired the courage with which he bore so valiantly ill health, will always remember him with affection.

He leaves a widow and two daughters, to whom we extend our sincere sympathy in their bereavement.
