

ALBERT INDERMAUR †

We sincerely regret to announce the passing away, at the end of last month, of Mr. Albert Indermaur, of 31 Gloucester Street, S.W.1, at the age of 63.

The deceased was for many years employed as a chef de cuisine in various first-class London and Provincial hotels, and occupied a prominent reputation in his profession.

Albert Indermaur was for a great number of years one of the most active members of the "Union Helvetia", London, first as a committee member and then as President of the London section, as well as President of the General Administration, and Chairman of the Club House commission. He retired from his various posts which he had held in this Society, in 1945. In addition he was for 14 years Director of Ceremonies in the Lucullus Lodge.

For the last few years he had been in failing health, and consequently was not seen much in the Colony; the latter loses in Albert Indermaur a man who has rendered conspicuous services not only to his Society, but also to the London Swiss community in general, and all those who have known him will keep him in affectionate memory. He leaves a widow to whom we extend our sincere sympathy in her bereavement.

CHARLES TH. LEHMANN †

We announce with regret the passing away, on October 19th, of Mr. Charles Theodore Lehmann, of "Culverale", 5, Culverden Park Road, Tunbridge Wells, in his 83rd year.

The deceased was born in Switzerland, and came to this country at the age of nine. Although he became naturalised, he frequently visited our country and he remained at heart Swiss.

Mr. C. Th. Lehmann had spent all his life in close connection with the condensed milk trade. He was Chairman and Managing-Director of R. Lehmann & Co. Ltd. since 1900, and Chairman of Ceylon Wharf (Bankside) Ltd. and the Zenith Electric Co. Ltd., Director of S. D. Simond & Co. Ltd., and of The Anglo-Saxon Condensed Milk Co. Ltd. He had been also a Fellow of the Institute of Directors since 1946.

Being an enthusiastic mountaineer, he became in 1932 a member of the Alpine Club, and a Founder Member (1909) of the Association of British Members of the Swiss Alpine Club, in which he had held the following appointments: Librarian (1919-1928), Treasurer (1926-1954) and President (1937-1945). On November 20th, 1948, Mr. Lehmann was elected a "membre d'honneur" of the Diableret section of the Swiss Alpine Club. He represented his Association on many occasions at the Annual Banquets of the City Swiss Club.

All those who have known Ch. T. Lehmann will keep him in good remembrance. He leaves a widow to whom we express our deep sympathy in her loss.
