The films were especially good this year and I think all the children would have loved to have been with the Swiss children trying to ski. "ALL FOR ONE AND ONE FOR ALL!"

The January Meeting of the Swiss Mercantile Society was devoted to a discussion, to which the members of the Nouvelle Société Helvétique had been invited, of the proposed "Solidaritätsfonds — Fonds de solidarité " for Swiss living abroad. The presence of the Swiss Minister, Monsieur Armin Daeniker, and several of his collaborators, who provided much authoritative information, added to the interest of the meeting.

Details of the draft scheme were given by Dr. H. W. Egli, whose recent article on this subject in the Swiss Observer will be remembered. A lively discussion followed of examples of insurance, loss and compensation. There was clearly a wide measure of interest in the scheme, although it was generally assumed that in the event of war the British authorities would again provide insurance cover against loss of property for all residents. On the other hand, insurance against "Existenzverlust perte de situation" certainly constituted a valuable innovation. The suggested premium of one per mille was generally considered to be reasonable.

In his concluding remarks Dr. Egli addressed a strong appeal to the Swiss Minister to impress upon the Swiss Federal Authorities the importance of giving the scheme their support right from the start. Being on voluntary and co-operative basis, it could only succeed if the largest possible number of Swiss living in foreign countries would join from the beginning and their participation would be greatly encouraged by official financial backing. By providing this, the Swiss authorities could in their turn cover themselves against future claims for compensation, such as had been made upon them by compatriots who suffered loss and hardship during the last war.

The whole matter is obviously still in a preliminary stage and a great deal more information will be required before every Swiss abroad can decide whether he should become a member of the scheme or not.
