Annual General Meeting.

The Annual General Meeting of the "Schweizerbund" (Swiss Club) took place on Saturday, February 23rd, at 74, Charlotte Street, W.1.

Mr. F. Delaloye was in the Chair, and there were about 50 members present.

The President in his Annual Report dealt at some length with the financial position of the Club, which he described as "unsatisfactory", this being partly due to a considerable decrease in membership fees and increased expenditure for repairs, etc. "If this Club is to be carried on," he said "it is essential that members take more interest". Mr. Delaloye made a strong appeal to all members to give more active support and to intensify their efforts to obtain new applicants. He informed the Meeting that the Hon. Secretary, Mr. R. Weist, owing to illness, had had to relinquish his post some time ago, and he warmly thanked Mrs. M. Schneeberger for having taken his place for the time being.

The auditor of the Club then explained the balance sheet in detail, which closed with a considerable deficit. After a short discussion both the President's report and the accounts were accepted.

For the election of a new committee no names were put forward. Mr. W. Meier took the chair *pro tem.* and it was largely due to him that a new committee for the next financial year could be presented. Before the elections took place the temporary chairman thanked the outgoing president and committee for the services they had rendered to the Club. He joined the outgoing President in his appeal for an intensified activity, making various suggestions such as reducing the subscription, etc.

The result of the elections was as follows:— President, F. Delaloye; Vice-President, H. Caluori; Hon. Secretary, Mrs. M. Schneeberger (temporary); Hon. Treasurer, J. Fischer; members of the committee: Messrs. Turmer, Henry, Bravo, Bonomo, Hausler, Michele, Mrs. Oggier, and Miss Friedrich.

In assuming the Chair again Mr. Delaloye thanked Mr. Meier for his efficient conduct of the Meeting, expressing the hope that the newly elected officers would ensure the Club a more prosperous future.

Before closing the meeting the President introduced to the company the new stewards, Mr. & Mrs. Rudiham, expressing to the former stewards Mr. & Mrs. K. Caluori his appreciation for services rendered.
