# Farewell Dinner to Consul J. J. Huber and Mrs. Huber.

The Farewell dinner offered by the Nouvelle Société Helvétique (London Group) to Consul J. J. Huber and Mrs. Huber, on Tuesday, June 18th, at the Swiss Hostel for Girls, 9 Belsize Grove, N.W.3, was a very happy affair indeed; although it was to a certain extent an official function, it had nevertheless the character of a friendly family party.

Amongst about 60 members and friends present were the Swiss Ambassador and Madame Daeniker.

Previous to the dinner being served, Mrs. Huber was presented with a beautiful bouquet as a small token for the many services she had rendered in the past.

Towards the end of the dinner, and after the usual toasts had been proposed by the President, Mr. W. Renz, the latter, in a short address, paid a sincere tribute to both Mr. and Mrs. Huber. A most enjoyable evening which had an intimate cachet thus came to a close, and both Mr. and Mrs. Huber, on leaving us, will have witnessed once more how much they have been appreciated, and how we wish them success and happiness for their future.
