We regret to record the death in London, on 18th February, of Mr. Walter Eichenberger, of 1 Chestnut Close, N.14.

Mr. Eichenberger, who was educated in Burg and in Reinach, joined the staff of the Swiss Bank Corporation in 1910. From 1920 to 1923 he was attached to the Geneva Office of the Corporation and, from his return to London until ill health compelled him to retire, was a well-known figure in the foreign exchange dealing room of the bank.

He was a keen supporter of the Arsenal football club and a well-known figure at the Highbury ground.

His courageous efforts to carry on his business activities in spite of crippling disability in the last years of his service at the bank earned him deep respect among his friends and colleagues. We express our sympathy with his widow and family in their loss.


It is with regret that we hear from Manchester of the passing away of Mr. Fritz Meyer and Mr. Rudolf T. Gschwind.

Mr. Meyer, of Wattwil (Ct. St. Gall), was an Honorary Member of the Swiss Club Manchester, joining the Club in 1905. In November 1956 he retired to Zurich, where he died on January 24th 1958, at the age of 77. Mr. Meyer held at one time the posts of Hon. Treasurer and Librarian.

Mr. Gschwind joined the Swiss Club Manchester in 1949, and for three years occupied the office of Hon. Secretary. He was born in Manchester of Swiss parents, and died on January 25th at the Manchester Royal Infirmary. Mr. Gschwind leaves a widow and a daughter.
