In one of our recent issues we acquainted our readers of the long services rendered to the well-known catering firm of Lyons by the family Delaloye.

To-day we are pleased to report another case of long and faithful duty, rendered to the same Company by Mr. H. Caluori, who after forty years in the employ of his firm retired a short time ago from the management of the Strand Corner House.

Mr. Caluori was born at Bonaduz (Ct. Grisons) in 1892 and came to this country in 1912. He joined Lyons in 1918 and has been associated with many of the Company's most famous establishments. Starting as supervisor at the old Popular Café, he moved in 1929 to the Coventry Street Corner House as Assistant Manager, and in 1931 he took charge at Olympia. After a short period as Assistant Manager at Maison Lyons, Marble Arch, in 1934 and 1935, he became Manager of the Oxford Street Corner House, and, in 1943, Manager of the Strand Corner House, which post he held until his retirement.

In spite of the responsible positions which he has held during periods of great excitement, change and stress, he has found time to relax, and in his leisure hours he took up boxing, wrestling and swimming, and in the last-mentioned sport he became most efficient.

Mr. Caluori also took an interest in the life of the Colony. He is a member of the Union Helvetia, and of the "Schweizerbund" — in which he held the office of Hon. Secretary for two years, and that of Vice-President for four years.
