

#### NOUVELLE SOCIETE HELVETIQUE. Annual General Meeting.

It has been the practice, when the autumn and part of the winter social season had passed, for the Swiss Societies to hold their Annual and General Meetings, in order to give an account of their activities.

These Meetings used often to be rather dull affairs, especially when one had to listen to the depressing statements of the respective Treasurers, who invariably — at least for the last few years — reported small or large deficits.

For some time now a number of Societies have combined these Meetings with a dinner, which I consider is quite a good idea; it shortens the business part considerably as everyone is anxious to "get it over" — looking forward to the second and more pleasurable part!

The General Meeting of the Nouvelle Société Helvétique took place on Tuesday, 18th March, at the Swiss Hostel for Girls, 9, Belsize Grove, N.W.3, and was followed by a dinner.


Mr. W. Renz was in the Chair, and a very large number of members attended, amongst them the Swiss Ambassador, Monsieur A. Daeniker, and a few official guests.

According to the Annual Report, which had been sent out to the members a few days previous to the Meeting, the Society has been again very active during the last twelve months, under the efficient and enthusiastic leadership of the President, Mr. W. Renz, who last year had taken over from Dr. H. W. Egli, who had for many years carried on the work of the Society with great competence.

The Agenda, which consisted of eight items, was despatched in almost record time. The annual report of the Council (which will be published in a subsequent issue of the "Swiss Observer") was accepted, and so was the Hon. Treasurer's report. So as not to make an exception concerning the accounts of their sister societies in London, a deficit of nearly £40 was reported. As at present no less than five Presidents of Swiss Societies in the Metropolis are Bankers, or otherwise connected with Banks, it is to be hoped that in future the finances will improve !

All the former members of the Council were reelected, two members dropping out for reasons of their departure for Switzerland, namely Dr. P. Bohny and Miss L. Meierhofer, Hon. Secretary. Mr. A. L. Chapuis, of the Swiss Embassy, was newly elected to the Council.

Mr. A. F. Suter, Hon. President of the Society, who had taken the Chair *pro tem*, before announcing the result of the elections, warmly thanked the outgoing Committee and Council Members for the services they had rendered, and congratulated them on their re-election.
