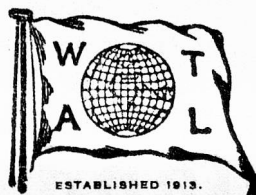
MEMORIAL SERVICE FOR THE LATE HENRY OSWALD.
