NEWS FROM THE COLONY.



M. WIESENDANGER,
Chairman of the Presidents Assembly 1959 to 1960

On the occasion of the Swiss Presidents Meeting, which took place on Monday, 1st June 1959, at the Swiss Embassy, Mr. M. Wiesendanger was elected Chairman for 1959/1960.

The new Chairman, who is also Chairman of the Swiss Economic Council, was born in 1897 in Zurich, where he attended the primary and secondary schools. Then followed a three-year apprenticeship with the firm of Escher Wyss Zurich. On its conclusion he entered the "Institute Minerva", Zurich, for a one-and-a-half-year course, which finished with matriculation. Mr. Wiesendanger was then admitted to the Federal Institute of Technology (ETH) Zurich, where on completion of his studies he obtained the degree of "Diplom Ingenieur" for his dissertation on Hydro-Electric Power Stations.

In 1923 Mr. Wiesendanger decided to go to the U.S.A., where he took up a position as research and design engineer with Messrs. Baker Perkins Co., in Saginaw (Mich.); he stayed there for five years. In 1928 he was offered a position as special representative for technical rubber goods by the Goodyear Tyre and Rubber Co. On accepting, he was sent to Berlin to be in charge of the Central European section. Owing to the economic crisis prevailing at the end of 1929 the company closed down their offices in Germany, and he returned to Zurich, joining the Escher Wyss concern.

In the early days of 1930 Mr. Wiesendanger was sent on a special mission to South Africa to study and analyse the market there. This trip, which was originally intended to last about six months, was extended to over two years' duration, after which he was recalled and put in charge of the firm's London Office, which position he holds to-day.

We wish Mr. Wiesdangar a successful year of office.
