#### SWISSAIR'S FINANCIAL RESULTS FOR 1959

Swissair's final accounts for 1959 show total revenue for the year at 278 million Swiss francs ( $\pounds$ 23,166,000) and expenditure, after appropriations to depreciation at 270 million ( $\pounds$ 22.5 million). This compared with revenue of 252 million Swiss francs and expenditure of 247 million in the preceding year.

Net profit for 1959 was 7,498,110 francs (£625,000) to which is to be added the previous year's carry-over of 403,670 francs.

Ordinary and supplementary depreciation account for 31.3 million francs (£2.6 million).

The Board of Directors has recommended a dividend of six per cent for 1959 (same as for 1958).

In addition, 800,000 francs are to be allocated to statutory reserve and one million francs to the staff pension fund. A balance of 431,780 francs is to be carried over for 1960.

# SWISSAIR MANAGEMENT APPOINTMENT

Mr. Max A. Landolt has been appointed Swissair's Sales Manager for the U.K. and Ireland in succession to Mr. M. A. Keller, who became General Manager at the beginning of this year. Mr. Landolt took up his new position at the beginning of March.

He joined Swissair in 1957 and in the following year was appointed Manager for Singapore, Malaya and Indonesia as first Swissair representative for that part of South-East Asia.
