The announcement that Dr. E. Froelich, the President of the Solidarity Fund of the Swiss Abroad, is coming to London in November coincides with the report from Berne that the guarantee the Confederation has so generously granted to the Fund will have come into effect from 20th October. This decree could be made valid only after no use had been made of the referendum within the legally prescribed period ending on 26th September. This is a tremendous step forward.

During the last two years we have all heard plenty about the fund — or so we think. But recently many important changes have been made and new questions arise. Who would be in a better position to answer them than one of the chief architects of the Solidarity Fund, an expert on insurance and a loyal friend of us Swiss abroad — Dr. Ernst Froelich himself?

Please come to the Open Meeting of the Nouvelle Société Helvétique on Tuesday, 13th November (see advertisement). He will be speaking *in English* on the progress made.

We have been on the brink of war — we were lucky this time but shall we be spared a next time? This should make us think twice and compel us to join the Solidarity Fund to help others at the same time as ensuring help for ourselves in an emergency.
