## Changes at the Swiss Bank Corporation

At the last extraordinary General Meeting of the Swiss Bank Corporation shareholders, Dr. Samuel Schweizer was elected a further member of the Board of Directors of the Bank. At the subsequent meeting of the Board of Directors, Dr. S. Schweizer was elected Chairman as from 1st January 1962.

Moreover, Mr. Charles Türler, President of the General Management, retired at the end of 1961 upon attaining the age limit. During his untiring activity over a period of 47 years, Mr. Türler has rendered most valuable services to the Swiss Bank Corporation.


To Mr. Homberger, a very well-known personality of the Swiss Colony in London, we offer our most hearty congratulations.

## Round and About

The fourth International Salon of Outdoor Activities will be held in Lausanne from 3rd to 11th March 1962. This exhibition, which will occupy part of the premises of the Swiss National Autumn Fair in the Palace of Beaulieu, will cover an area of over 132,000 square feet this year, i.e., 60 per cent more than in previous years. This International Salon will have a very large number of foreign exhibitors and is expected to have great success among all camping enthusiasts and those interested in outdoor activities. It will also include an nautical section, showing some of the latest models of motor and sailing boats, as well as an enquiry centre giving information on camping sites in Switzerland and abroad. A number of special events of interest to tourists will also be arranged to coincide with the Salon.

### Big Swiss Technical Achievement

The first of the four steam turbines ordered by the Department of Water and Power of the town of Los Angeles from Brown-Boveri and Co. in Baden has just successfully undergone its final factory trials in the presence of a representative of the famous American city. It should be mentioned that this is the first time such a powerful machine of this type, a turbine of 230,000 kW with a single line of shafts, has ever been made.
