NEWS FROM THE SWISS BANK

The Swiss Bank Corporation announce that at the end of 1962 Mr. H. Droz, a member of the General Management, retired after over forty years' service with the Bank. The Board of Directors has newly appointed Mr. H. Strasser (previously Manager of the Berne Office) to be a General Manager with effect from 1st January 1963.

Retiring from the London Office are Mr. D. E. Bonnet, Mr. R. W. Callan and Mr. W. S. Firth. Prior to joining the Bank on 1st January 1921, Mr. Bonnet had been associated with the traditional watch industry in Bienne. Popular in the Bank, he served for exactly 42 years in the General Correspondence Department. Aside from his professional activities, however, Mr. Bonnet is well known in the Swiss Colony, particularly through his connection with the Swiss Benevolent Society, for which he has acted as Hon. Assistant Treasurer continuously since 1947, and through his association with the Nouvelle Société Helvétique, for which, for many years, he has acted as auditor. Since the early post-war years he has sung as first bass in the Swiss Male Choir, and he is also a member of the Swiss Sports Committee. It is hoped that the Swiss Colony will not lose his services on the occasion of his retirement.

Mr. R. W. Callan, an Attorney of the Bank, had nearly completed 44 years' service, all of which was spent in the Commercial Credit Department. Few people, even in the City, can have attained such a wealth of experience in this sphere in which he had become an acknowledged expert. Prior to joining the Bank in 1919, Mr. Callan had served as a pilot in the Royal Flying Corps and, subsequently, in the newly born Royal Air Force.

Mr. W. S. Firth, who joined the Bank in November 1922, saw experience in bookkeeping and Foreign Exchange before being entrusted with the technicalities of the virtual evacuation of the Bank to its war-time country home at Byfleet, Surrey. Subsequently, he took charge of the Bank's archives at Gayhurst, Northamptonshire.

Newly promoted to the rank of Attorney are: Mr. E. J. Frey, Mr. H. Jauslin and Mr. L. W. D. Powles.
