## FEDERAL PLEBISCITE

The Swiss electorate went to the poll on 8th December. There were two proposals which the Swiss citizen had to approve or reject. One was the "Finanzordnung", a proposition to continue the present finance regime for another ten years, and the other was a scholarship article to the Federal Constitution. As had been expected, both were accepted, the former by 474,640 to 136,891 and the latter by 481,812 to 131,647. All the Cantons accepted, but the voting participation was a mere 40.3%. Now that the two proposals have been accepted, the way is clear for a number of important provisions. Several drafts concerning taxes are already on the parliamentary agenda, among them a reduction of the defence tax ("Wehrsteuer") and a revision of the withholding tax ("Verrechnungssteuer"). The latter will also affect the Swiss outside Switzerland, and the Organisation of the Swiss Abroad has this matter in hand; it will be discussed at the next meeting of the Commission of the Swiss Abroad on 1st February in Berne.

## THE FEDERAL BUDGET FOR 1964

The budget of the Confederation envisages expenditure of 4,434 million francs and revenue of 4,877 million francs for 1964. The surplus of 443 million francs would be much the same as in 1962 (432 million francs). There is anxiety in some quarters as to the increase in income and expenditure which is around 15 to 20% compared with the budget for 1963. Agriculture, military and civil defence and national road construction figure amongst the heaviest items.

The budget reckons with personnel in the service of the Confederation amounting to 26,517 people, about five hundred more than in 1963. The figures are made up of 16,200 civil servants, 5,030 employees, 4,600 workers and 687 professors at the Federal University of Technology (ETH), Ambassadors, Ministers and army unit commanders. The total cost is expected to be thirty-seven million francs higher than in the budget for 1963 and sixty-four million francs higher than the actual cost in 1962. Total expenditure for personnel is expected to amount to 463.4 million francs.
