# NEWS FROM THE COLONY

## CITY SWISS CLUB

### Annual General Meeting

In spite of the fact that the date clashed to some extent with the Easter holidays, the City Swiss Club's Annual General Meeting held on the 20th April 1965, brought thirty-four members and four guests to the Dorchester. After an excellent dinner, the company — nicely mellowed — was called to order by Mr. M. A. Keller who was in the chair. He offered a warm welcome to the meeting and expressed his particular pleasure at the presence of His Excellency The Swiss Ambassador who is the Club's Honorary Chairman, and the very strong delegation from the Embassy in Messrs. J. Revilliod, E. Tosio, R. Zellweger, G. Franel. Messrs. M. Heimo and H. Gallusser had apologised.

The minutes of the previous meeting were read by the Secretary and accepted unanimously.

In the President's Report Mr. Keller gave a brief review of the year's activities. He said that whilst the attendance at our meetings had been somewhat better than in the previous year, he felt that there was still considerable room for improvement. The 99th Annual Banquet and Ball had, on the other hand, been a roaring success and he was pleased to have this opportunity of handing to Mr. J. Zimmermann a cheque for £90 which had been raised on that occasion for the Swiss Benevolent Society. Mr. Zimmermann expressed his and the Society's gratitude, and the President resumed his report expressing his thanks to the retiring Committee for their support and wishing the new Committee every success for the future. His remarks of appreciation addressed to Messrs. G. A. Ronus and A. Kaeufeler for their contribution to the Club's success were vigorously applauded from the floor.

In his report, the Hon. Treasurer drew attention to the excess of income over expenditure which had risen from £45 to £154 mainly due to increased profits from the Annual Banquet and Ball and the Dinner Dance at Great Fosters. Membership fees in arrears, not included in these figures, were down from £50 to £20. On the recommendation of the Auditors, the accounts were accepted unanimously.

Mr. Th. v. Speyr who had kindly agreed to conduct the elections of the Committee as Chairman *pro tem* announced that both the President and the Vice-President were obliged to withdraw due to pressure of business. Mr. E. Bonvin and Mr. C. Nater had kindly agreed to accept nomination and all the other Committee members were prepared to continue in office. The retiring Committee's list of nominations was accepted unanimously in an open block vote.

Mr. Bonvin then took the Chair and expressed his appreciation for the trust and confidence placed in him and his fellow Committee members. He warmly thanked the retiring Committee members, particularly Mr. Keller, for the time and effort so unstintingly expended in the service of the Club during their tenure of office and expressed the hope that we could count on the continued support of the Embassy. He announced the dates for the two most important events of the year, the Dinner Dance at Great Fosters on 2nd July and the 100th Annual

Banquet and Ball on 19th November which he hoped would receive maximum support.

Mr. C. Chapuis as the oldest member present then addressed the meeting in a few well chosen words in which he looked back into past years and wished Mr. Bonvin and his fellow members a happy year.

The Meeting was closed at 9 p.m., early enough for quite a few of the members to enjoy a friendly drink or two in the informal atmosphere of the Dorchester Bar.
