THE NEW PRESIDENT OF THE CITY SWISS CLUB



At the Annual General Meeting, Mr. Carl Nater was elected President of the City Swiss Club. He hails from St. Moritz where he was born on 2nd January 1909. He went to the local schools, including the "Handelsschule" which has since ceased to exist. Then, he went to Geneva to work at the Swiss Bank for three years. After his apprenticeship there, he did his *Rekrutenschule* in Chur.

It was in November 1929 that Mr. Nater came to London where the firm of Cartier Ltd., the well-known jewellers in Bond Street, allowed him to spend a year or so with them in order to improve his knowledge of English. But Mr. Nater is still there today. First, he was an assistant to one of the senior salesmen and then became a salesman himself.

After a few years, Mr. Nater wanted to know a bit more about precious stones and spent some considerable time in the buying department. He was made a director of the company in 1946. During the 'fifties and early 'sixties, he was sent to India almost every winter to buy precious stones. In the course of business, he also visited Bagdad, Kuwait and America. In 1951 and again two years later, the firm sent him to Canada to investigate the possibilities of starting business, there, though without any further consequences. Mr. Nater also visited Australia and Hongkong.

It was in 1935 that he married, and the Naters have three daughters, one son (who is in Australia) and five grandchildren. Mr. Nater is a very keen and active ski-ing expert.

We congratulate him on being elected President of the City Swiss Club which he joined on 7th December 1937, and wish him every success in the new office.

We announce with deep regret the death of Dr. C. Devegney. He died suddenly on 18th May at his consulting rooms at 8 Upper Wimpole Street, W.1.

Dr. Devegney hailed from Geneva where he was born in 1892. He came to this country from Naples in 1923. For many years, he was the *Médecin de Confiance* of the Swiss Embassy, and up to his death, he was official medical doctor of the Lycée Français in Kensington. He was also a member of the Company of the Swiss Hostel for Girls. Though he has lived a quiet life, especially during the past ten years or so, he has many friends who mourn his passing.
