high up on the terrace overlooking the *piazza*, or indeed of the listeners.

Lunch with a *vin d'honneur* was enjoyed on the boat, and entertainment was provided by a girl's choir and two mandolin and guitar players. The journey home went along the other side of the lake, via the Melide "Roman-tica" and the Capo San Martino. The Assembly dissolved about 4 o'clock on returning to Lugano. Some of us missing the farewell ceremony remembered from former *Journées*.

All said and done, it was a good gathering. If I were to pick out one item that impressed me most during the three days, it would be the fervent multilingual singing of "*Grosser Gott, wir loben Dich*" at the Ecumenical Service, when all our worries, hopes and apprehensions were offered to the One without whom our efforts as human beings and as dedicated *Auslandschweizer* are of no avail.
