
PERSONAL

SWISS CULTURAL CENTRE IN LONDON

We reproduce here a news flash which has reached us by courtesy of the Swiss Telegraphic Agency (Agence Télégraphique Suisse). It is an exact translation.

"Berne, 3rd July. In answer to a small enquiry by National Councillor Dr. E. Tenchio (K. Chr.) Grisons, regarding the erection of a cultural centre (Swiss Forum) within the Swiss Centre in London, the Federal Council replies that in this centre, whose creation is due to private initiative, the building of a multi-purpose room is planned. This could be made available for events of cultural, economic or social character and will have the name "Forum of Switzerland".

'The erection of the Forum gives rise to a number of questions. A working group is dealing with them. On it are represented the interested parties (Confederation, Foundation "Pro Helvetia", Swiss National Tourist Office, Federation of Swiss Societies in Great Britain, undertakings of private industry, etc.). Thus, the co-ordination of the parties concerned is assured, for which the Political Department in particular has been striving. Arising from the plans available up to now, the costs for creating and

running the Forum are relatively high."

"The view of the Federal Council is that building of Forum should cost not more than 1.9 million francs. With this, the available possibilities for financing would be taken into account adequately. It is planned — subject to agreement by the Federal Councils (Parliament, Ed.)
— to grant a federal contribution of Fr.800,000.— towards the erection of the Forum. Indispensable is reliable evidence (especially estimates, plans, running cost estimates, a finance plan). A foundation according to Swiss law is visualised as juridical representative. The efforts to realise the whole plan are being continued."
