## CO-OPERATION BETWEEN BROWN BOVERI AND SULZER

The Swiss machine industry is one of the most important pillars of Swiss exports. In the past year, exports totalled 15 milliard of francs, a third of which was from the machine industry. The latter has to face stronger and stronger international competition, resulting in higher investment and research costs which become a steadily increasing burden. In order to be fully competitive, any duplication and overlapping as well as dissipation of labour and strength must be avoided. This is the reason why, at home and abroad, mergers of large concerns have taken place.

Sulzer Brothers combined with Escher-Wyss in 1966, and Brown Boveri took over nearly 99% of the share capital of MFO (Maschinenfabrik Oerlikon). It must be stated that these were not take-overs, but mergers (*Zusammenschlüsse*).

The companies Brown Boveri/Maschinenfabrik Oerlikon (MFO) and Sulzer Brothers/Escher-Wyss have agreed to co-operate and have clearly defined their production programmes. The main features of this co-ordination are the foundation of a new company "Brown Boveri-Sulzer Turbomaschinen A.G. Zürich" ("TAG") for the development, construction and sale of gas turbines and turbo-compressors, which have hitherto been produced successfully by both concerns. Escher-Wyss will hand over the steam turbine business to Brown Boveri as from 1st January 1969 and produce steam turbines for Brown Boveri.

The capital will be 10m. francs, of which the two concerns have equal shares. Both companies are represented equally on the board. The Chairman will be nominated alternatively by the two groups, the first will be Mr. P. Schmidheiny of Escher-Wyss.

In the case of co-operation Sulzer-Brown Boveri, it was not only a question of co-operating more closely in the field of gas turbine and turbo-compressor construction, but to extend this co-operation also to the two Zurich companies MFO and Escher-Wyss. The new company thus brings about, apart from production, a clear definition of the production programme as such, a thing which would have been unthinkable a few years ago. This solution will allow the further use of the know-how acquired by the collaborators in the "Commun Department", a continuous use of production capacities and with it maximum favourable distribution of labour.

At a press conference early in February, it was pointed out that such co-operation was not in any way the result of any wish for monopoly, but simply the consequence of technological development and of large markets. It was also stated that no co-operation had been organised yet with Sulzer with regard to reactor research.
