The Chairman reported that in order to be exempt from paying income tax on the income from our investments, the Committee has taken steps to be registered under the Friendly Societies Act 1896 to 1960 and Charities Act 1960.

Mr. Walter Bion has been elected at the last Annual General Meeting of the City Swiss Club as its new President, in succession of Mr. Alfred Kuhn.



Mr. Bion springs from a Huguenot family which emigrated to St. Gall in 1707. He is therefore a citizen of that city, and in addition is an Honorary Citizen of Zurich. Born on 4th April, 1913, he went to school at the Berne Gymnasium and then passed a commercial diploma in Basle. He joined the Bally Shoe Company at Schoenewerd in 1932 and was sent by them to England in 1937, where he remained throughout the war.

In 1943 he married a Londoner, Miss Barbara Joyce Thomas. They have a son, Richard, born in 1946, who is a B.Sc. Honours and who has a diploma of Industrial Administration.

Mr. Bion is Managing Director of Bally's Shoe Company Ltd., who are wholesalers and sole agents for all Bally products in the UK and some other territories. Since 1971 he has also been appointed as co-ordinator for the activities of their factories and the retail organisation in the UK (Bally Shoe Company). 
SWISS BANK CORPORATION— RETIREMENTS

Nearly half a century of service terminated with the retirement of Mr. André Jaccard from the London Office of the Swiss Bank Corporation at the end of April.

Mr. Jaccard joined the Geneva Office of the Bank on 4th July, 1921, as a lad of 15 years; he came to London as long ago as 1930 and thus stayed to share in the vicissitudes of the war years. Promoted to Attorney in January, 1950, he took charge of the Staff Office from May, 1951, from which post he now retires.

Although he was a one-time member of the now, alas, extinct Swiss Male Choir, Mr. Jaccard will be best

known through his long association with the Swiss Mercantile Society of which he is now President, an honorary but responsible post which he has held since 1963.
