# NEWS from the COLONY

## MRS. ARNOLD STAHELIN

It is with deep regret that we announce the death of Mrs. Catherine Helen Stahelin, *née* Clark. She died at the home of her son John, 54, Junction Road, Norton, Stockton-on-Tees, on Teeside, on 15th January.

Kate Stahelin, as she was known to her friends, came from Farneth near Dunkeld in Perthshire. Before her marriage to Arnold Stahelin in France in 1919, she worked in the Post Office Savings Bank in London. The young couple went to Switzerland where their two sons John and Charles were born in 1920 and 1922 respectively. In 1923, the family returned to their home in Thornton Heath, Surrey.

Her husband Arnold Charles was born in 1891 in Zurich. He trained as a

silk expert and came to this country in 1914, but returned to Switzerland to do his military duties when the first world war broke out. He had worked with Ducharme & Cie, a leading firm of silk manufacturers in Lyons, and on his return to London, he was appointed manager and later managing director of the London branch of Ducharme & Cie. He retired in 1962.

Arnold Stahelin was an active member of the Swiss Mercantile Society whose President he was from 1925 to 1928. He was closely connected with the formation of the Society into a company limited by guarantee. He was made an Honorary member both of the SMS and the mother Society in Switzerland in recognition of his sterling services. He was a well-known personality in the Swiss community and much respected for his clear thinking and integrity. He was also a very keen Freemason and held high offices.

They were a well-matched pair, Kate and Arnold, and he was very proud of his wife's Scottish descent. His friends often considered his wit as being akin to that of North of the Border. They were both members of the London Perthshire Association. Although Kate was not as prominent as her husband in the Swiss community, she was much liked and respected. The death of Arnold at 74 on 7th February, 1966 was a great blow not only to her and her family, but also to the Swiss community.

Mrs. Stahelin's great hobbies were gardening and embroidery as well as bobbin lace making. In her later years, she was a rather reluctant traveller, but she kept her interest in Swiss affairs. She spent a happy 80th birthday with her sons and grandchildren at the Swiss Centre in London. It is to her family that we express our deep sympathy. She has

now gone to join her husband, and we shall remember them as the remarkable couple they were.

## FRANK CONRAD

We have the sad duty of announcing the death of *Mr. Frank Conrad* at the age of 78 on January 1st. A former member of the Helvetica Lodge, the City Swiss Club, the Swiss Mercantile Society, the Swiss Rifle Association, the Secours Mutels and one-time President of the Swiss Male Choir, Mr. Conrad was a well known and active member of the Swiss community in this country. Mr. Conrad was compelled by declining health to retire over a year ago to a Hotel in St. Gall. His widow is also in Switzerland living in a hospital.

Born on 15th March, 1896, a citizen of Bermgarten (Aarau), Mr. Conrad came to this country in 1921. He managed a firm in Belfast where he acted as agent for a variety of textile goods. He also ran his own agency in London for embroidered goods and handkerchiefs. He leaves a widow, a daughter and two sons and many grand-children. To them all we extend our most sincere condolences.

## Political Rights for the Swiss Abroad

On 15th November, the London Group of the Nouvelle Société Helvétique held a discussion on the draft law regarding political rights for the Swiss abroad. A 45-page report issued by the special commission set up by the Federal Council, was summarised by the Society's President, Mrs. Mariann Meier, who led the discussion.

Members present were unanimous in their opinion that political rights should only be granted to those Swiss who pay taxes in Switzerland and/or do military service. The Swiss community in Great Britain is in the minority with this attitude, and the two delegates to the Commission of the Swiss Abroad have repeatedly voiced that opinion. They are by no means alone, but unfortunately, the report gives the impression that all Swiss abroad are in favour.

It was realised at the meeting that the wheel cannot be turned back, and

that most likely political rights will be granted in the near future. But members regretted that if the draft law is accepted and Swiss resident abroad are permitted to take part in federal plebiscites provided they are in Switzerland at the time, three classes of Swiss abroad would be created, viz those who have the time and the money to travel to Switzerland in order to vote, those who live near Switzerland's frontiers and the "have-nots" whose circumstances would never or only rarely permit them to take part in a plebiscite. The meeting was of the opinion that, in the interest of equity and equality voting by post should be possible. Naturally an effort would have to be made, and previous registration with the Swiss Embassy or Consulate would be essential.

The meeting expressed concern about absolutely impartial and neutral information regarding federal plebiscites. It was taken for granted that all information should be brought to the communities by the "Review", in Great Britain the four special numbers of the "Swiss Observer". A great deal of responsibility will fall on the Swiss editorial committee to ensure impartial information.

Members were also unanimous that on no account must Swiss communities abroad be used for political agitation and party-political propaganda.

The discussion was followed by a short report on the Assembly in St. Gall, given by the two London delegates to the Commission, Mrs. M. Meier and Father P. Bossard.
