The Article in the Federal Constitution pertaining to the Swiss Abroad

Article 45bis was inserted in the Federal Constitution after it had been accepted in the federal plebiscite held on 16th October 1966 by 491 220 votes to 230 483 and by all the cantons.

¹ The Confederation is entitled to further the relations of the Swiss living abroad amongst themselves and with their homeland and to assist institutions set up to that effect.

² It may, taking into account the special situation of the Swiss living abroad, issue regulations determining their rights and duties, in particular with respect to the exercise of political rights, the fulfilling of military obligations and to assistance. The cantons shall be consulted beforehand. This article represents a political testimony in favour of the Swiss abroad. For the first time, the existence of Swiss citizens abroad has duly and properly been anchored in the basic charter of the Confederation which thus offers the possibility to legislate with respect to Swiss living abroad, if necessary despite certain existing dispositions. The special situation of the Swiss compatriots living abroad, which is different from that of the Swiss at home, is taken into consideration, and the ties with their country of origin are strengthened.
