A truly memorable Federation meeting

THE 19th annual meeting of the Federation of Swiss Societies in the UK held at the Swiss Embassy was special on several counts.

Firstly, the Federation celebrated its 35th anniversary, having been created as Presidents' Assembly in 1949 by Dr H.W. Egli, the late Raoul de Cintra and Walter Meier.

Secondly, the president of the Organisation of Swiss Abroad, Prof Dr Walther Hofer, attended the meeting for the first time. He brought greetings from the executive of the "Little Parliament of the Swiss Abroad", the Commission (ASK).

Prof Hofer said that he had been living abroad himself, for over a year in the USA, and for nine years in Berlin. He was therefore familiar with many problems facing his compatriots

outside Switzerland.

He mentioned the Assembly of Swiss Abroad was held in Basle in conjunction with the Swiss Industries Fair, the Muba. This was by no means a novelty he said, as the first eight Assemblies from 1919 to 1926 had been held in Basle with the Muba.

He stressed the importance of Swiss foreign trade and the valuable contribution and constant efforts thousands and thousands of Swiss were making.

Prof Hofer also mentioned the ever greater sacrifices Swiss abroad had to make in a time of rapidly growing political and economic difficulties.

He reiterated some of the successes of the ASK during the past year, in particular with regard to the citizenship campaign and the AHV, and he thanked Mrs

Meier for her valuable work as delegate for 22 years.

He announced that next year, the Assembly would again take place at the end of August, at Interlaken or Gstaad, and he hoped to see a larger delegation from Britain than this year.

The third reason why the meeting was special was the fact that the president, Mr Bernard Simon, was in the chair for the last time, as he was relinquishing his office after 10 years.

He welcomed the Swiss Ambassador, Monsieur Charles-Francois Pictet, whose first AGM as hon. president it was. He thanked him for his interest and also for his and Madame Pictet's hospitality.

Next, he greeted the two Consuls, Monsieur Charles Glauser from Manchester and Monsieur

Claude Duboulet from London, but above all the Minister at the Swiss Embassy, Monsieur Claudio Caratsch.

He thanked him for all his help during his years in London and wished him success in his new post.

Apart from Prof Hofer, Mr Simon welcomed another guest from Switzerland, Mr Marcel Ney, director of the Secretariat in Berne – no newcomer to the Swiss in Britain.

Mr Ney later made an impressive appeal to purchase 1st August Badges which this year were sold in aid of institutions benefiting Swiss abroad, such as schools, the Secretariat of Swiss Abroad and the Solidarity Fund.

The president extended a welcome to the hon vice-president, Dr H.W. Egli and the large number of presidents who had come from many parts of the UK, though unfortunately quite a few members were ill or absent abroad. Still, the meeting was very representative and able to deal with the business expeditiously.

The minutes, the president's and treasurer's reports, as well as that of the auditors were accepted with thanks.

Though all four delegates to the commission (Mrs Mariann Meier and Mr Joe Broggini for the south, and Mr Bernard Simon and Dr Ursula Ditchburn for the north) were present, it fell to Dr Ditchburn to report on the work of the commission and the ASK meeting in Basle.

Mrs Meier, as member in her own right of both the Council of the Solidarity Fund and the Com-

mission on Information, reported on the meetings she had attended and drew particular attention to the Solidarity Fund.

The report by the fact-finding ad hoc Committee on Cooperation was accepted and the committee given a further mandate to continue its work.

The President then reported on the negotiations between the Federation, the "Swiss Observer" managing editor (unfortunately absent due to illness) and the authorities in Berne regarding the renewed incorporation of the "Review" in the S.O.

It was hoped to conclude an agreement soon and to resume quarterly publishing of the "Review" as part of the "Swiss Observer".

As mentioned before, the meeting was the last under Mr Simon's chairmanship. He thanked the members for their support and said that his work had been made more difficult due to being resident in Manchester and not in London.

The Ambassador took the chair during the elections. He thanked the outgoing president for his sterling work for the past 10 years. His successor was elected in the person of Mr E. Tangemann, hitherto vice-

president of the Federation. Mr F. Koch (president City Swiss Club) was the new vice-president.

The hon treasurer, Mr Albert Kunz, and the hon secretary, Mr Virgil Berti, were re-elected.

Mr Simon resumed the chair for the remainder of the meeting and proceeded with the election of the two delegates and their deputies to the commission.

This brings us to a further reason why the meeting was memorable: he announced the retirement of Mrs Mariann Meier after 22 years on the ASK, for well over a decade the only woman with 60 and 70 men.

She had been a member of the Federation for 26 years, first as president of the Welfare Office, then as editor of the "Swiss Observer" and then as president of the New Helvetic Society.

He thanked her for her devoted and effective work and announced that the committee would co-opt her. Mrs Meier then addressed the meeting, and her farewell speech earned her a standing ovation.

The company then adjourned to the residence where dinner was served. After an excellent meal, the Ambassador addressed the gathering and again mentioned the invaluable work

done by Mrs Meier and by Mr B. Simon.

Thus a memorable evening came to a close, and if members took Mrs Meier's words to heart, there may be a new beginning for the Federation with the societies taking a much more active part.

Mr Roland Mathez

IT is with deep regret that we announce the death on June 2 of Mr Roland Gaston Mathez, of 50 Vincent Court, Bell Lane, Hendon, London NW4.

Roland Mathez was born in the Jura. He worked in the Banque Populaire Suisse, Tramelan, and then for two years in a bank in Frankfurt before he came to this country in 1926.

He obtained a post in the Ionian Bank where he met his wife Ruth. It is there, too, that he became friendly with a well-remembered compatriot, the late Maurice Rothlisberger.

In 1933, he joined a firm of merchant bankers in the City and specialised in stocks and shares. Eventually he was based in Zurich.

Mr Mathez was closely con-

nected with the Swiss Church already at the time of Pasteur Hoffmann-de Visme, and later when Monsieur Pradervand was minister, followed by Pasteurs Reverdin and Nicod.

He was elected to the Consistoire of the Swiss Church in 1947.

In 1926, he had joined the Union Chrétienne de Langue Francaise, under Mr Alfred Brauen, who was president of the Consistoire and died in 1962 at the age of nearly 100.

Mr Mathez's great hobby was philately, and he was a keen member of the London Swiss Philatelic Society. He also belonged to the City Swiss Club, the Swiss Mercantile Society and the New Helvetic Society.

Many of his Swiss and British friends attended the cremation at Golders Green Crematorium on June 7 after a funeral service at Christ Church, Hendon. They were grateful to know that he did not have to suffer greatly, and although he died suddenly, the end was peaceful.

We shall remember Roland Mathez's kindly personality with affection and express our deep sympathy to his wife and daughter in their grievous loss.

The weather was sunny and rather windy but we were assured these were the best conditions for gliding.


Many who had not booked to glide decided to do so after talking to and watching others.

Chairman retires

MR Hans Strasser chose London for one of the receptions to mark his retirement as Chairman of the Swiss Bank Corporation and to introduce his successor, Mr Franz Galliker, who took over on July 1.

The reception, held at Carpenters Hall, London, was

attended by more than 200 guests, including leading figures in international banking, as well as commercial customers of London office, stockbrokers, money brokers, representatives of discount houses, and other personalities.

Guests also met Mr G. Streichenberg, general manager with responsibility for London office.

Mr Strasser's guests also included the Rt Hon. The Earl of Inchcape, international adviser, Messrs U. Buhler, D. Linder, and P. Muller, directors of the bank, Mr W. Fehner, general manager, Mr W. Schick, central manager, and Mr A. Butz, manager attached to the general management.

Also present were senior executives of Swiss Bank Corporation International, as well as members of London office management.

Carpenters Hall is the home of one of the City's older liveried companies. The date of the foundation of the Brotherhood of Carpenters is not on record but there is evidence that it existed before 1333.

The first Carpenters Hall existed in 1428 and added to during 1550/1665.

In 1666, during the Great Fire of London, the halls of many

liveried companies were destroyed. Carpenters Hall, however, was lucky to suffer no damage as it was surrounded by gardens which acted as a fire-break.

A new hall was completed in 1880. Although it escaped damage during the First World War, it was severely damaged in September, 1940, and was finally destroyed in May, 1941, during later air raids.

The present hall, which preserves the main elevations of the old one, was opened in 1960, by the Lord Mayor of London.

During the morning of the reception Mr Strasser and London office chief manager, Mr R.E. Amstad, were received at Mansion House by the Lord Mayor of London, Dame Mary Donaldson.

In the afternoon Mr Strasser, accompanied by Messrs Streichenberg and Amstad, saw the Governor of the Bank of England, Mr Robin Leigh-Pemberton.

We wish Mr Strasser a long and happy retirement shared with Mrs Strasser. At the same time we offer our good wishes to the new chairman, Mr Franz Galliker.
