A recruit who has done his first service at a later date than the appointed time is entitled to re-imbursement of the military tax paid for the year in which his own class had been recruited. The request for the refund must be made within five years of his military services as a recruit.

SWISS INDUSTRIES FAIR AT BASLE.

An official reception was held at Basle of the Swiss diplomatic and consular representatives abroad. Amongst the many distinguished compatriots was Monsieur Paravicini, our Minister, who as a Balois was naturally singled out; in the local papers his photo appears surrounded by a group of attractive "Baslermaitli." In a humorous speech delivered after the traditional "Imbiss" Monsieur Paravicini admitted that this was his first visit to the Basle Fair; a Basle manufacturer had recently drawn his attention to the enormity of that omission and he hoped that he had now atoned for this unheard-of crime.

According to official statistics published last month 67,400 civil servants and workmen were in the service of the Swiss Confederation at the end of 1929. Of this number 35,300 belonged to the Swiss Federal Railways whilst the remainder were distributed in the general administration, the postal and customs departments.

The Swiss and Dutch police authorities are straining all their resources to discover the whereabouts of the golden penholder used during the signing of the Locarno Pact. Along with another dozen of historic mementoes it was despatched to the Hague for exhibition.

The clerk to the Permanent International Court at The Hague has informed the press that according to official communications received both from the French and Swiss Governments the direct negotiations have not led to a satisfactory settlement of this long outstanding dispute. The International Court has now fixed July 31st as the date by which the respective documents with comments have to be lodged; counter proposals and legal arguments have to be submitted by September 30th, 1930. It is anticipated that judgment will be delivered some time in October.

BOYCOTT OF AMERICAN GOODS.

The Federal Council has received numerous protests against the proposed increases in the United States tariff. The Federal Council is giving this matter full attention.

As a reply to the arbitrary raising of import duties by the U.S.A. on watches, in some instances become

by over 300 per cent., Swiss Watch interests are appealing to offices, factories and garages to re-frain from buying or dealing in any goods of American origin.

FOOTBALL.

At the international match played on the ground of the Grasshopper F.C. in Zurich between Germany and Switzerland last Saturday the visitors scored with five goals to nil. The match was favoured by beautiful weather and witnessed by a record attendance of about 25,000.

AMERICAN UNIVERSITY DEGREES.

The Federal Tribunal in Lausanne has upheld a decision of the Zurich authorities by which a local business firm was debarred from making use for propaganda purposes of medical degrees granted by spurious American universities. The decision affects the principal of the well-known Scholl concern which specializes in Orthopedic products.

The Société Fermière Astra Ltd. was regis-tered in Glarus in 1923. Having gone into Liquid-ation in the autumn of 1929, it was declared bankrupt last February; fraudulent bankruptcy

bankrupt last February; fraudulent bankruptcy is alleged, and the chairman, an industrialist from Bern, has been arrested. He was allowed bail in 50,000 Frs. The business of this company was the manufacturing abroad of oils and fats.

According to the "Neue Glarner Zeitung" the assets totalled more than 750,000 Frs., the paid up Share Capital amounting to 250,000 Frs. Although another company's claim against the Fermière Astra Ltd. of more than 400,000 Frs. was not satisfied, the members of the Board received twice the value of the shares as profits; the remaining assets were also disposed of. Now they show a deficiency of about 460,000 Frs. including the unsatisfied claim.
