## CHANGES AT THE SWISS EMBASSY IN LONDON

During the last few weeks there have been several changes in the diplomatic and consular staff at the Embassy.

**Monsieur Marcel Heimo**, First Counsellor, left with his family for Kigali, the capital of Rwanda, at the end of January, having been appointed Legal and Economic Adviser to the President of Rwanda by the Swiss Federal Council. Monsieur Heimo has been succeeded at the Embassy by **Monsieur Jean-Denis Grandjean**, until recently Deputy Head of the Swiss EFTA Delegation in Geneva.

**Colonel Werner Koch**, Defence Attaché, departed from this country with his family on 16th March to take up his duties in the same capacity in Washington D.C. His successor, **Colonel Wilhelm Frei**, formerly an Instructor in the Swiss Air Force, has already started his tour of duty in the United Kingdom. Colonel Frei is accompanied by his wife and a daughter.

The Assistant Defence Attaché, **Captain Peter Storrer**, returned to Switzerland on 27th January with his wife and small daughter to take up an executive appointment as Head of the electrical project department of the Bernische Kraftwerke. He has been replaced by **First Lieutenant Friedrich Lanz**, who arrived recently with his wife and two small children.

**Vice-Consul Fritz Burgunder**, Head of the Consular Chancery, and Mrs. Dorli Burgunder left England on 18th February. After a long and successful term of office here Mr. Burgunder has been transferred to Los Angeles, where he is First Assistant to the Consular General. He will shortly be replaced in London by **Monsieur Charles Abegglen**, at present Vice-Consul in Tel Aviv, Israel.

We wish all our departed friends success and happiness in their new fields of activity. To the new arrivals in this country, we extend a warm welcome and wish them a happy and successful stay.
