The Committee is very concerned that this should be quality colour rather than cheap colour for colours sake, but this is being thoroughly investigated for at least one issue in celebration of 20 years of the Society.

Lastly, I would like to take this opportunity to wish you all a Peaceful and Joyous Christmas followed by a Happy and Successful New Millennium.

## **SECRETARY'S NOTES - Brian Hemming**

When one approaches the end of the year thoughts turn to the next year and what it may hold in store. As Secretary it inevitably means that attention must be paid to the procedures of the Society and in particular the Annual General Meeting. The formal notice for the AGM appears elsewhere in this issue as does a Society advertisement giving details of the various activities associated with the traditional Spring Meet.

With the support of, and in conjunction with the East Midlands Branch plans are well advanced for the weekend which is at the present time the only opportunity all the members have to attend a full Society function. Thoughts have been expressed at previous AGM's that the Society might organise functions in addition to the Spring Meet, and the matter is under active consideration by the Committee. No decision has yet been reached, but I would be very pleased to hear from any member who has any views on the subject not only for the form such a "Reunion" or "Meet" might take, but where or when it could be held.

A number of matters considered at the last two Committee meetings are dealt with elsewhere in this issue. However, the most important was the decision to increase the UK Annual Subscription to £11. We have managed to hold the subscription at £10 since 1995 but we



must ensure that the Society remains solvent particularly in the light of possible cost increases. The decision was not taken lightly, but we believe this modest increase will contribute to the overall well being of the Society, Swiss Express and the services offered to the membership as a whole. We do hope the increase will not deter you from renewing your subscription.

At last we can report progress on the subject of Credit Cards. Through the kind offices of our friends at the German Railway Society we will be able to offer, as their agents, a limited credit card facility. The Committee has authorised this initially for a 12 month trial period and it will be limited to Subscriptions from Overseas Members and Society Sales via Steve Horobin (Sales Officer) or Andy Nelson (Publicity & Exhibitions Officer). It is proposed that transactions be limited to £10 minimum and £50 maximum. Further details will appear in due course, but Overseas members will find a Credit Card option with their renewal form.

We have been able to tidy up a couple of matters relating to the Society in this electronic age. At the present time four members of the Management Committee are connected to the Internet, and we have now established e-mail addresses to a common format, not only for these officers, but for those who are not yet "connected" These will be applicable to the office with safeguards being built in to ensure security when an office changes hands.
