RULES & REGULATIONS

Season Tickets (Abonnements généraux) available for 15, 30 or 45 days are issued all the year round at any of the Booking Offices of the Railway Companies whose systems are shewn in red on the other side. These Tickets are also issued in London at the Official Agency of the Swiss Federal Railways, Carlton House, 11 b, Regent Street, Waterloo Place, S.W. (Office hours: 9 to 6; Saturdays 9 to 2) and by Cook's Office, Ludgate Circus, E. C. and their Branch Offices in Great Britain.

Conditions of issue:

1º Season Tickets are issued at the following prices, which include a deposit of 4/- (see rule 10):

No reduction is made for children.

2° An unmounted photograph of the person for whom the ticket is to be issued must accompany the order for same. The photograph must be carte-de-visite size, the height of the head being not less than three-eighths of an inch. Smaller photographs will not be accepted.

The photograph must not have been previously used for a similar purpose, and must remain affixed to the ticket. 3° When applying for Season Tickets, passengers must indicate the date on which they wish the period of availability to commence. Tickets may be dated in advance, but not more than 8 days ahead of the actual date of issue. Season Tickets cannot be used in advance of the day for which they are dated. The validity of the ticket expires at midnight on the 15th, 30th or 45th day, and can under no circumstances be extended.

4° Each ticket must bear the Holder's signature.

5° During its validity a Season Ticket entitles the holder to an unlimited number of journeys by all trains and boats shewn in the official time-tables.

6° On all steamboats, 2nd & 3rd class tickets are available 1st & 2nd class respectively.
7° The holders of 1st class Season Tickets wishing to travel by one of the International Sleeping Car Company's «trains de luxe» must pay the supplemental fares prescribed by the tariffs. The holders of 2nd or 3rd class tickes wishing. to travel by the said trains must, in addition, pay the difference between the second or third and the 1st class fares. 8° Season Ticket holders are requested to retain their tickets in their possession and produce them opened whenever

required to do so, otherwise the ordinary full fare will be charged, and will under no circumstances be refunded. Qo Season Tickets are not transferable.

The ticket will, with the deposit, be confiscated if any alterations are made to it by the holder, or if it is transfered to any other person, who will, in such case, be called upon to pay the ordinary full fare and be liable to prosecution. 10° The deposit (see rule 1) will be refunded upon the ticket with photograph attached being surrendered: a) In Switzerland, before 2 p. m. on the day after expiration, at any of the Booking Offices of the Railways or Steamboat Companies concerned. The ticket can also be sent by post to any of the said Booking Offices, but must be posted within the stipulated time. b) In England not later than the second day after expiration at the Official Associated the Official Associated to the Device Proton Protocology.

The deposit is forfeited if the ticket is not surrendered, or if it is surrendered too late, unless a further ticket be taken dated in continuation of the first.
11° No refund is granted for lost 15-day tickets.
Only in exceptional cases (death or illness proved by medical certificate) is any allowance made for partly-used tickets, and then only for those available 30 and 45 days.
