## **SECRETARY'S NOTES - Brian Hemming**

At the last meeting of this year, held on 14th October, the Committee considered two very important topics and made decisions that will, we hope, have beneficial effects on the success of the Society. Colour in future issues of Swiss Express was considered in depth and the outcome of our deliberations are discussed in the Chairman's notes. Suffice it to say that there will be two issues containing colour in 2001, and there will be no increase in the subscription. This has been made possible by careful management of the Society's finances by our Treasurer, Ian Athey, and stringent cost control in the production of Swiss Express by David Stevenson, the Editor,

After a trial period of a year on sales and overseas subscriptions it had been decided that credit card facilities will be now offered for all subscriptions, and at the same time the upper limit for transactions has been increased to £100 (the minimum transaction of £10 will still apply). The use of credit card facilities does incur a cost to the Society which we feel is not appropriate should be borne by those not using the facility, and therefore a surcharge of 5% (minimum £1) will continue to be applied to each transaction.

The increased use of credit card facilities has brought about a significant change in the manner in which we will in future handle subscriptions from Australia and New Zealand. For two years we have had a system whereby each of those countries has had a Coordinator to deal with subscriptions paid in local currency. Unfortunately disadvantageous exchange rates and bank charges for the transfer of funds to the UK have made this a costly exercise for the Society. The Committee has therefore decided to revert to the previous requirement that subscriptions from Australia and New Zealand, as with the rest of the world except the USA, be paid in pounds sterling by cheque drawn on a UK Bank. However, there is now the opportunity to pay by credit card, and although, as mentioned previously, this will incur a surcharge the overall cost will most likely be lower than obtaining a bank draft. We would particularly like to take this opportunity to thank both Victor Isaacs (Australia) and Sean Millar (New Zealand) for the efficient manner in which they have operated as Coordinators for the overall benefit of our relatively small, but valued, Australasian membership.

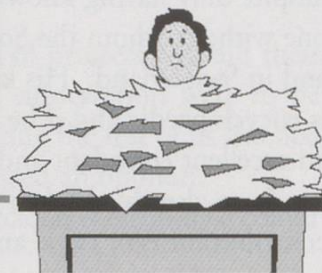

The renewal form for all members for 2001 subscriptions is included with this issue. All completed renewals should be forwarded directly to the membership secretary. Subscriptions for 2001 have all been held at last year's level. Following the trial period of allowing overseas members to pay by credit card this facility is now extended to all members. This scheme is operated for us by the German Railway Society and no cost is borne at all by the Swiss Railways Society but it does carry a 5% surcharge with a minimum of £1 for members. This means that UK members paying by credit card would be charged £12. All members should note that it is possible to pay for two years' subscription and this would save postage for you and slightly reduce any credit card surcharge. Members would also make a saving if subs were increased in the following year! USA members may still forward a US dollar cheque but payment for all other overseas members must now be in sterling, whether by credit card or by cheque or draft drawn on a UK bank and payable in the UK. The Australian and New Zealand bank accounts have now been closed, as reported elsewhere in this issue. Each renewal form has the appropriate subscription rate on it.

The following members have prepaid for 2001: K3, K48, OH117, OJ105, OQ42, OV46, OV62, OV68, OV74 & V70

All members receive a renewal form with Swiss Express. If you have pre-paid please ignore it.

Please note that a small stamped, unaddressed envelope would be appreciated from UK members only for the return of membership cards. All correspondence included with your renewal form, relating to the AGM and/or Dinner should be on a separate sheet from renewals and any Dinner payments must be on a separate cheque.

For your convenience a credit card payment slip for AGM Dinner payments has been included on the insert sheet. The aim is to give a speedy and efficient service and members should know their renewal has been received and processed by the return of their membership card and the encashment of their cheque. The number of renewals for 2000 is 1037 (Mid October), very slightly up on last year. I shall be present at the Mirfield exhibition on December 9th 2000 where members may renew and receive their new membership card.

Swiss Express has just received a copy of the LRTA book, Tramways and Light Railways of Switzerland and Austria, written by Richard Buckley and published by LRTA.
