It is with great regret that I have to report the death on 6<sup>th</sup> November 2004 of our first President at the age of 79.

He was a very private person and a gentleman in the true sense of the word. I knew little about his work but I understand he became the Financial Director of the Swiss Locomotive and Machine Works (SLM) in Winterthur. Even after his retirement he was very active on behalf of the company travelling as far afield as, for example, China.

I had the pleasure of visiting him and his wife Rosa (an enthusiastic philatelist) at Hettlingen near Winterthur and was impressed by the fact that he travelled daily to and from work by bus, an example that might well be followed by others wherever good quality public transport is available.

His knowledge of Swiss railways and technical railway matters in particular, as his many articles in *Swiss Express* demonstrate, led many to believe, initially myself included, that he was an engineer.

His modesty was such that some years ago he asked to stand down from the Presidency because he felt unable to play a sufficiently active part in Society affairs. Despite my best efforts I was unable to dissuade him but his continued contributions show his lasting interest in our Society.

On behalf of all members of this Society, I express our condolences to his wife and family.
