CHAIRMAN'S NOTES Paul Russenberger

On behalf of the Society, I would like to extend to Herr Rudolf Steinmann the Society's congratulations and best wishes for his term in office on his election to the Presidency of the SVEA.

After being elected, he gave a short presentation introducing himself, and you can read about it in my report on the SVEA meeting in the December issue. He cited a matter that the SVEA should address as being the need to attract younger members. At the same meeting the Gemeinderätrerin praised railway modelling as a hobby which spanned the generations and could be a grandfather and father and son thing. There are many examples of well known father-and-son railway partnerships, including at least one within this Society. My father-in-law was a railway enthusiast, but none of my children are, so it may not be genetic.*

We do not ask the age of members when they join. However, it is probable that the SRS is experiencing a rise in the average age of members. Since we are also experiencing a long term rise in the size of the membership (no remarks about obesity, please!), this is not of immediate concern. However increasing average age is a phenomenon experienced by many other organisations – the local photographic society where I'm a member is facing the same issue.

It is probably a societal trend across the UK if not Europe. Entertainment activities have altered over the years and the train set is not the universal childhood diversion it used to be. I wonder if Switzerland as a family holiday destination has maintained its relative position compared with 40 years ago. Certainly when I first went in 1958 (!) it ranked above France. In those days people took holidays which they arranged themselves or possibly used a travel agent (in the true sense) to make reservations in hotels and bookings on scheduled transport on their behalf. Package tours to Spain (or Switzerland!) were unheard of.

To be absolutely brutal, I can suggest no possible solution to a rising age profile. That does not mean that there isn't one – just that it isn't obvious to me. Your ideas on a postcard (or etc), please.
