New Felisol pattern cards

The ten dyestuff manufacturer members of the Felisol Association (International Association for the Felisol Fastness Label) have published a set of new pattern cards, each manufacturer presenting his own dyestuffs in a separate volume. The products mainly belong to assortments of vat dyes and naphthols, the dyeings or prints made with these dyestuffs on cellulosic fibre fabrics being eligible for marking with the Felisol label, owing to their high qualities of fastness. An introduction contains particulars concerning the legal and technical regulations governing the use of the Felisol label. The pattern cards of the various dyestuff manufacturers on the other hand, give all technical information, details concerning the commercial forms of dyestuffs as well as dyeing and printing recipes. For each dye, the cards give samples of the shade when dyed and when printed, as well as the minimum depths for washable articles, interior decoration and use in the open air. These new pattern cards will certainly be welcomed by all finishing concerns. It should be added that the Felisol Information Bulletin No. 16, which was published at the beginning of the year, is devoted entirely to the new pattern cards.

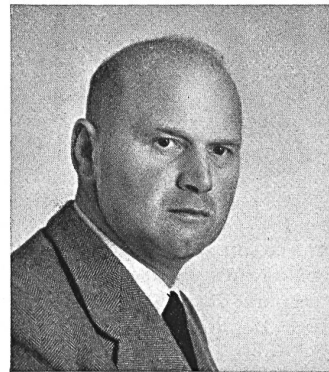
A new finishing process for wool

The Swiss office of Joseph Bancroft & Sons Co., in Zurich, announces the launching on the market of a new process, called « Bancora », for the finishing of wool. Thanks to this process, which has no ill-effects either on the wool fibre itself or on the fastness of the colours, the fabrics and articles treated by it can be washed by machine without damage, and at the same time keep a far better look and handle than those treated by other processes. This new process can be applied to the finished products as well as to the ribbons of worsted. The « Bancora » process will be used in Switzerland under licence, in the field of knitted fabrics for outer-garments and hosiery, by Raduner & Co. Ltd., at Horn.

Swiss chemical fibres to the fore

Société de la Viscose Suisse, Emmenbrücke, recently presented some of its synthetic yarns at the International Spring Fair in Frankfurt. The display, on a stand in the main hall 3, naturally included finished products such as woven and tufted carpets, upholstery fabrics and curtaining, pullovers and fabrics for women's wear, all marked with the « Flixor » ® quality label. Nylon 6 is used for the manufacture of fishing nets, ropes, tarpaulins and tyre casings. Viscose and nylon flocks marked with the « Nylflock » ® and « Fliscaflock » ® quality labels respectively are used today for the manufacture of furnishing fabrics, carpets, fabrics for clothing, wall-papers, etc. The very attractively presented stand was liberally supplied with samples for distribution to those interested, who were also able to obtain information from the very competent staff on duty there.
