WINNERS IN THE MIDDLE EAST

**Swiss Carpets capture contract business.
Stamflor Swiss successful bidders against
strong international competition.**

When Swiss carpet manufacturers Stamm decided to expand their involvement in the Middle East four years ago, the timing was right. All target markets in that area continued to enjoy a building boom, unparalleled elsewhere. Furthermore, contractors and architects – through trial and error – were ready to recognize the investment value of a high-quality carpet product. On their side, Stamm had several assets to offer:

- A strong position and extensive know-how acquired in supplying a home market, which is probably one of the most demanding in the world.
- A product mix comprising a standard line, an interior design line and a troubleshooter line, to meet the diversified needs of the trade.

Meeting Market Requirements

Carpet requirements in Middle Eastern countries focus on two distinctly different end-uses: Heavy pure new wool velours and berbers for residential use, and heavy-duty, long-lasting synthetic qualities for contract use. Due to climatic and laying conditions, special double backings of jute or polyester are a must.

Stamm Ltd., Eglisau, Switzerland's oldest tufting manufacturers, not only meet these product specifications but top them with an impressive range of services. The package includes expert advice on carpet selection, installation and maintenance, cut-to-measure facilities, reliable delivery by land or sea route to any destination in the Middle East, and a five-year guarantee on carpet performance.

According to Stamm export manager Thomas A. Henschke, current Stamflor Swiss bestsellers in the area include: *Terratwiss*, a berber-type polyamide loop pile construction, *Perltwiss Object I*, a striped

struction, *Woolstar*, a luxurious high-pile velours in pure new wool, and *Stellatwiss*, the polyamide loop pile novelty with glittering gold lurex effect, specially created to meet the taste of the Orient.

Banking on Stamflor Swiss

Among their past and present projects in the Middle East, Stamm take particular pride in coming out winners against heavy international competition for one of the area's most prestigious contracts. In 1982, the mighty Arab Bank contracted 6000 m² of Stamflor Swiss *Terratwiss* in three colorations to carpet the administrative section of their new building in central Amman. Deciding factors were the natural berber-look of the carpet, which adds warmth to an otherwise strictly contemporary corporate setting, and its hard-wearing properties. Based on ground plans submitted, Stamm drew up installation plans, cut all carpeting to exact room measurements, and supervised on-site fitting.

A year later, in the course of office reorganisation, some removable room partitions had to be shifted, revealing deep impression marks in the carpet pile. Yet, within a few days all marks had completely disappeared. This visual demonstration of pile recovery in a quality carpet and other practical proofs of high-performance properties resulted shortly after in a further order of approximately 4000 m² *Terratwiss* to refurbish Arab Bank's downtown branch.
