# Report on SASEG's 88<sup>th</sup> General Assembly, 3 September 2022, Hotel Astoria, Olten

## 1 Welcome and Opening

Draft of the minutes to be adopted at the 89<sup>th</sup> general assembly in 2023.

The president Bernhard Gunzenhauser welcomed the 30 participants of the 88th general assembly at the hotel Astoria in Olten. For the first time in the history of VSP and SASEG the general assembly was held separately from the annual convention with its scientific presentations and geological field trips. This event has taken place in June 2022 in Acqui Terme in Piedmont and some 52 members and partners have enjoyed interesting presentations and marvellous excursions to outcrops of the Tertiary Piedmont Basin led by our committee member Prof. Andrea Moscariello.

It was hoped that for this year's general assembly with its important topic on the future strategy of SASEG it would be better to have ample time and convene at a centrally located venue in Switzerland in order to get as many participants as possible. However, despite several reminders to all SASEG members only a relatively small number participated.

The annual convention included the general assembly and lunch, followed by Strategy presentation and participation of members for future of SASEG.

As president of the day for agenda points 6) and 9) Matthias Bichsel and Christian Minnig as vote counter were proposed by the president and both were elected unanimously.

ing for Geo-Energy in the Tertiary Piedmont Basin (TPB). Sunday and Monday excursions led by Andrea Moscariello at the vicinity of Acqui Terme and presentations by renowned experts on the geology and its geo-energy resources of the TPB.

**A special excursion** to the geothermal drilling site at Lavey-les-Bains took place on 6 May 2022.

**Bulletin Vol. 26/1 & 26/2, 2021** contain in total 175 pages, 20 articles of which 6 on geo-energy, 9 on engineering and hydrogeology, 1 on reflection seismic, 1 minutes of SASEG GA in Frutigen, 3 obituaries. High quality contributions and excellent work by editor Roger Heinz. Swiss Bulletin of Applied Geology website was recently revamped and is now also in French & English.

**SASEG new Website:** The new website is available since December 2021 in German, English and French. An Italian version is in preparation and will be published later 2023. The steering committee thanks Werner Leu for the energy and work put on the new website, as a result it looks modern and is always worth a visit.

**Next Annual Convention** will take place 17-

19 June 2023 in Montreux. Field trip leader will be Prof. Jon Mosar (UniFR) assisted by Prof. Stefan Schmid (ETH-Zürich).

**SASEG Student Grant:** our member Dario Schwendener has completed his master thesis project at ETHZ on «Velocity quantification of two-phase drainage and imbibition processes in rough wall fractures» and was financially supported by the grant.

**Future of SASEG:** In the afternoon of the 3rd September 2022 Martin Stäuble will present the new strategy for the association based on the data received from the inquiry made among the members in late 2021. The presentation will be followed by a workshop during which the present members will voice their opinion and view. The steering committee will compile the propositions and present a programme on the next general assembly, 17-19 June 2023.

#### **4 Treasurer's report: Financial statements 2021**

The treasurer Res Fraenkl presents the balance sheets of the past association year.

Overall situation: The overall financial situation of the SASEG remains healthy, an asset increase of CHF 4'240.83 was observed in 31.12.2021 (see also in Table 2).

## 6 Discharge of the members of the managing committee

Matthias Bichsel asked the attendees of today's general assembly whether they would give discharge to the managing committee for the year 2021. The assembly agreed unanimously.

## 7 Editor's report

R. Heinz reported, in addition to the President's remarks, that the next Bulletin (Vol. 27/1, 2022) is in print and contains 11 articles with 5 external contributions, 2 contributions from presentations of the SFIG conference and the conference report SFIG, 1 book review and 2 obituaries. For the next issue of the Bulletin, Vol. 27/2, 2022, there are 8 articles registered with a main focus on the landslide in Brienz/Brienzauls.

An outlook for the first edition in 2023 can already be given: Due to the conference on the Gurten in October 2022 in Bern on the subject of CO2 storage the first Bulletin Vol. 28/1, 2023 will be a special edition with their contributions.

On the SASEG (and SFIG) website a specific membership area has been implemented to get access to the latest (2 years) Bulletin volumes, which are ready to download as well. A password will be communicated to all members early autumn 2022.

## 8 Farewell to two management committee members

Michael Gysi and Stefan Heuberger (secre-

tary) were elected as committee members by the general assembly 2019 in Geneva.

Due to a heavy load in their professional and family life, both unfortunately had to resign as committee members of SASEG. We will miss their strong commitment, their factual and informed contributions as well as their camaraderie. In the name of the committee, the president sent both a letter of appreciation and a farewell gift.

## 9 By-Elections to the management committee

Bernhard Gunzenhauser explained that Matthias Bichsel would act as President of the meeting and would therefore chair the by-elections.

The CVs of the proposed candidates Nicole Scheidt and Rodney Garrard were presented to the audience and both were elected as new members of the managing committee by acclamation for the remaining period 2022-2023. Nicole Scheidt will replace Stefan Heuberger as secretary.

## 10 Decision on Membership Fee

The proposal of the managing committee to keep the member fee at CHF 80.- per annum for personal members was adopted by the general assembly.

## 11 Annual Convention 2023

The 89th annual convention for the year 2023 will take place in Montreux from 17-19 June and will include the general assembly, scientific presentation and two days with field trips in the area. The detailed program is currently (autumn 2022) worked out and the

invitation with the final program will be sent out in February/March 2023.
