Notice to authors

"Candollea" publishes original scientific papers on the systematics, morphology, chorology and ecology of plants and on subjects closely related to phytotaxonomy. As a general rule, manuscripts should not exceed 30 pages and should be addressed anonymously to the Director of the Conservatoire and Jardin botaniques in Geneva. Longer papers may be divided at the editor's discretion and published in successive instalments.

The papers submitted are judged by an ad hoc editorial committee and, if necessary, by an expert specially appointed for this task. Their opinion and the editor's decision will be communicated to the authors.

Only clearly typed manuscripts are accepted (two copies, if possible, the original being on stout paper), with wide margins and double spacing (4 notches). Authors are earnestly requested not to underline anything except latin plant names to be rendered in italics, with a single straight line.

As regards the presentation and arrangement of the text, citations of all types and bibliographical references, it is recommended to follow the example of the previous issues of this journal (from volume 34 onwards). In particular, the abbreviations of the titles of periodicals must follow the lines of "Botanico-Periodicum-Huntianum" (Pittsburgh 1968). For the citation of herbaria, the abbreviations used in the "Index herbariorum" (Regnum Veg. 92) are adopted. Indented keys should be avoided. Folded sheets of large tables or graphs are not to be used.

The rules of the "International code of botanical nomenclature" (Regnum Veg. 97) are rigorously applied.

Line drawings and graphs will be done in indian ink and numbered in pencil. Explanatory texts should be confined, as far as possible, to the title space. A metric scale should be associated to each figure. The grouping of the figures and their distribution in the text is a task incumbent on the editorial staff.

Inset illustrations on glazed paper of halftones (e.g. photographs) can only be done at the author's expense.

The reproduction of illustrations that have already been published elsewhere is to be avoided. If, however, for some special reason it should prove necessary to do so, it is the author's task to obtain the copyrights required.

The titles of the illustrations should be as concise as possible and grouped on a separate sheet. All indications pertaining to the scale magnification or reduction of the subject should be excluded.

An abstract in English and/or in French not exceeding 200 words should be submitted. The editorial staff will nevertheless approve final French and English versions of the abstract for each paper.

Contributors tacitly agree to cede all authors rights to the Conservatoire and Jardin botaniques publishers. This transfer becomes effective from the moment that the author receives written confirmation of the acceptance of his manuscript for publication. Intellectual property of the published scientific papers remains with the authors.

Authors receive, free of charge, 50 reprints without covers. Further copies up to 200 (and covers) can be supplied at cost price on written request. If the requested number of reprints exceeds 250, a special authorization should be obtained from the Director who will then stipulate the sale conditions.
