**SWISS MERCANTILE SOCIETY LIMITED.**

The Society held its 2nd Extraordinary General Meeting at Swiss House on Wednesday, June 10th. Mr. M. Paschoud, President presided. This Meeting was convened to pass the Bye Laws and to appoint the new Committees, as the last step in the alteration of the Society's status. The Secretary read the minutes of the first Meeting of the Company which were confirmed.

The Bye Laws, dealing with the internal regulations and management of the Society were read out by the President as submitted by the Council.

The new Bye Laws are a substitute of the old rules governing the Society's administration, but more condensed and less exhaustive than the latter, the most important matters being incorporated in the Society's Memorandum and Articles of Association as required by the Act.

Under the new constitution, the Entertainment Committee has been eliminated and its work will be carried out by the General Purposes Committee. The size of the Committees has been somewhat reduced owing to the existence of the Council which would make a larger number superfluous.

The various Committees will draw up more detailed regulations governing their department. The Bye Laws were passed by the Meeting with certain alterations and amendments.

**Election:**  
As an outcome of the Bye Laws the election of the Committees took place by poll. Messrs. M. Schneider and F. Conrad acted as scrutineers. The Committees were elected as follows:—

**General Purposes Committee:**

President: Mr. M. Paschoud; Vice-Presidents: Messrs. A. C. Stahelin and W. L. Krucker; Hon Secretary: Mr. G. Haberstich; Hon. Treasurer: Mr. O. Grob. Members: Messrs. R. Chappuis, W. Lehmann, P. W. Schoop and A. Steinmann.

**Education Committee:**

Chairman: Mr. A. C. Stahelin; Vice-Chairman: Mr. E. Hardmeier; Members: Messrs. H. H. Baumann, W. Meier, F. Streit and R. Weist.

**House Committee:**  
Chairman: Mr. W. L. Krucker; Vice-Chairman: Mr. J. J. Boos; Members Mrs. T. Langhi-Rezzonico and Mr. J. Trachsel.

Mr. A. C. Stahelin on behalf of the Education Committee and Mr. M. Paschoud on behalf of the Society thanked Messrs. J. J. Pfändler and J. H. Attinger, who relinquished their offices on the Education Committee, for the valuable and magnanimous services they had rendered to the Education Department and the Society during their term of office. Both members answered in suitable terms and although no longer serving on the Committee they assured the members of their continued interest in the Society's welfare. The President also welcomed Mr. Boos's return on the House Committee.

Mr. W. Burren, who was in charge of the Swiss Sports team, gave a concise report of the results achieved by our members at this year's Meeting at Herne Hill.

In order to enliven the social side a social evening was fixed for July 1st when all participants of the Swiss Sports will be invited. The Committee will spare no efforts in making the programme varied and interesting, and the President of the Swiss Choral Society, Mr. F. Conrad, who was present, assured us of his Society's assistance for this Meeting. The ladies will be invited for this occasion and it is hoped that a great number of members will come along to make the evening a complete success.

It was also decided to entertain a contingent of some 60 members from Switzerland, who will come to London for a "Studienreise" in August next.

It was also resolved that on account of the summer vacations no Monthly Meetings be held during the months of July and August.
