## SWISS MERCANTILE SOCIETY.

The Ninth Ordinary General Meeting of the Swiss Mercantile Society (Limited by Guarantee) was held at Swiss House, 34-35, Fitzroy Square, on Wednesday, February 14th.

Mr. J. J. Boos, President of the Society, was in the Chair.

The Secretary (Mr. J. J. Schneider) read the notice convening the meeting and the report of the auditor.

The Chairman then paid a last tribute to the late Federal Councillor Motta, who was five times President of the Swiss Confederation and for more than twenty years Minister of Foreign Affairs. M. Motta visited the College of the Society in February 1930 during his brief stay in London and the meeting rose in memory of the deceased.

The Chairman thereupon called on Mr. Percy H. Green, F.C.A., Auditor, who elucidated the accounts which had been circulated among the members. The results of the year under review were considered very satisfactory, taking into account the exceptional circumstances and the reduced working period. A resolution that the accounts be received and adopted was passed unanimously, and the auditor, Mr. Green, was re-appointed.

The Chairman then reported on the activities of the Society during the past year. Steady progress was made till end of August, when the outbreak of war upset all plans. Despite many difficulties, however, the Society held its meetings during the latter part of the year and the support received from the members encourages the Society to look forward to useful activities in the future. The membership showed little change, 16 new members having been admitted during the year, whilst 20 resignations were received, mostly from members who had returned to Switzerland where they joined local Sections. The President's report embraced full particulars of the varied activities of the Society, including social functions. Although the latter will have to be considerably curtailed during the period of hostilities, the Society will, nevertheless, do all in its power to keep the flag flying and rally its members. In conclusion the Chairman expressed thanks to the Federal Authorities, the Swiss Legation, as well as the numerous Subscribers and Donors, for their unstinted help which will enable the Society to carry on until such time as normal activities at Swiss House can be resumed, in the interest of both our country and our young compatriots.

Mr. W. Meier, Chairman of the Education Committee, gave a detailed account of the manifold activities of the Education Department. It was his sad task to record the closing of the College in November, after an existence of over 17 years. During the first six months of 1939 the monthly average attendance was the highest for 8 years, and although it would be futile to speculate on what figures would have been reached, had not fate intervened, the ever growing reputation of the College in Switzerland was evinced by the steadily rising number of students in the course of several years. It was little short of a tragedy when Swiss House, which for years had been a hive of industry and a seat of learning, suddenly became deserted of its youthful occupants. May the day not

be too distant when they will return to resume their studies which came to such an abrupt end. The report of the College included full details of attendance, staff curriculum, examination results, Holiday Course, excursions, lectures, social functions and sports, as well as particulars of Evening Classes. The reports were unanimously adopted with acclamation.

The Chairman then proceeded to the election. Mr. W. Beckmann was elected Chairman pro tem. and Messrs. M. Rothlisberger and F. von Bergen were elected scrutineers. Mr. Beckmann, on behalf of the Meeting, expressed thanks to the retiring Council and Committee Members for their valuable services rendered to the Society during the past year. He particularly complimented the Chairman on his magnanimous work during his first year as President and referred to his arduous duties during a particularly difficult year, when due to the special circumstances he had to bear the brunt of the work. Mr. Boos was thereupon unanimously re-elected President with prolonged acclamation. The Chairman, in thanking the meeting for the confidence reposed in him, expressed his personal appreciation to the members of the Council and the Committees for their loyal support and singled out for special mention the meritorious services rendered by Mr. W. Meier, Chairman of the Education Committee, for his untiring efforts and able guidance of the Education Department. It was found that under the prevailing circumstances the Education and House Committees were not required and it was decided to suspend them until such time as normal activities are resumed. The Meeting then proceeded to the election of the Council and the General Purposes Committee. There were two vacancies to fill, namely that of a Vice-President and that of Hon. Secretary. Mr. O. Grob, who for many years held the office of Hon. Treasurer, and during last year that of Chairman of the House Committee, did not seek re-election in his latter capacity, being at present in New York. Mr. M. Schneider, Hon. Secretary, joined the colours in September last and has now taken up an appointment in Switzerland. The Chairman expressed the Society's appreciation to the two gentlemen for their valuable services during a considerable number of years. All the other officers offered themselves for re-election. As a result of the election Mr. L. W. Krucker was elected a Vice-President and Mr. R. Chappuis was elected Hon. Secretary.
