

J. C. WETTER
President, Swiss Rifle Association

As reported in this issue, Mr. J. C. Wetter of 8 Carew Road, Northwood, Middlesex, — on the occasion of the Annual General Meeting — was elected President of the Swiss Rifle Association in succession to Mr. Alfred Schmid.

Mr. Wetter was born at Teufen (Appenzell A.Rh.) in 1896. He received his schooling at Teufen and afterwards at the *Ecole de Commerce* Neuchâtel. Like so many of his compatriots, in order to gain experience, he left his native country in 1916 for Paris where he spent two years with a firm of general merchants. During his stay there he was twice called back for military service in Switzerland.

In 1918, Mr. Wetter came to this country obtaining a post first with a textile concern and afterwards with a transport firm. Six years later (1924), he started his own business as agent for food processing machinery, later manufacturing his own machinery for meat and canning factories. In 1949, Mr. Wetter floated the company J. C. Wetter & Co. Ltd., with head office in Middle Street, E.C.1, which firm enjoys today a prominent reputation in the trade.

Although a very busy man — often travelling in various countries — he has always found time to take an interest in the doings of the Colony. He joined the Swiss Rifle Association in 1925, when the Society was re-formed, but has been connected with the former Society since after the first world war as a member of the committee. Being one of the "crack shots" he competed at various Federal Shooting Competitions, obtaining many trophies and distinctions.

Besides shooting, Mr. Wetter indulged in many sports. He was a keen mountaineer, climbing many of the "Viertausender" in the Swiss Alps. He was, and still is, an enthusiastic skier, a golfer and at one time a tennis player.

Mr. Wetter joined the Swiss Mercantile Society in 1918 and the City Swiss Club in 1929.

During his stay in this country he has been a faithful member of the London Colony, attending many of the social functions together with his charming wife. He has always been a generous supporter of many deserving causes concerning the Colony. Mr. Wetter has a married son and daughter, and one single daughter.

We wish him every success in his year of office.
