

chief fashion centres and to the raw materials placed at her disposal on every market, Switzerland is always in a position to offer novel fabrics to all her customers.



Switzerland produces silk and art-silk materials of every kind and at every price. There is the greatest variety in coloured and figured dress materials, ranging from the so-called « classic » goods to absolute novelties.
