Mr. H. Martin, Councillor of Legation, who took a very active part in the Special Commission, was present, a fact which was noticed with general satisfaction.

The president, Mr. E. Werner, gave an exposé of the The president, Mr. E. Werner, gave an expose of the position. He particularly pointed out that in order to get financial help within the Swiss Colony for the Education Department, which has been for years the pride of the S.M.S., the Society, i.e., the members, should commence to show their willingness to support this branch of activities.

Mr. J. Pfaendler read out the Report of the Special Commission and after a lengthy and thorough discussion the follows:

mission, and after a lengthy and thorough discussion the following recommendations of the above-mentioned body were accepted ing recommendations of the above-mentioned body were accepted by a large majority:—(1) All yearly subscriptions and donations of the contributing "passive" members shall go exclusively to the Education Department; (2) Increase of annual contribution for "active" members from 12s. to 18s., and "passive" members' subscriptions from 10s. to £1 1s.; (3) Fees for lessons to be increased approximately by one-third.
